

## COMPANY PROFILE

*Eastern Knit Wear Ltd* is a renowned Ready-made garments Manufacturer & Exporter in Bangladesh and is on this business since 2000. The production facility is **equipped with state of the art and latest modern machinery** to manufacture quality products **exporting to renowned and branded buyers of USA, Canada and ECC countries**. The factory is **located at the commercial capital and the main Seaport of Bangladesh** with added advantage for quick and timely shipment.

Eastern Knit Wear is an **equal opportunity employer** and believes in **cost effective quality production**. The staffs and workers are chosen purely on the basis of merit/ability to do the job **without any sorts of discriminations** on their personal characteristics or beliefs. Eastern Knit Wear enjoys reputation with in the trade organization (BGMEA) for its **“clean business practices”**. The company operates its business complying fully with applicable laws, rules and regulations, including those for workers wages, working hours and other facilities to the benefit of workers. Employment of labour under age of 18 (Child labor) and use of forced labor are prohibited in the company. Eastern Knit Wear is committed to use its best endeavours to **protect Health and Safety of all its employees** and safeguard surrounding environment and strictly follow its Health and Safety (HS) policy including for Fire protection and emergency evacuation. The company provides medical care for all its employees.

The Company gives its utmost importance to its Quality Assurance and Quality Control policy and has the following policies in place. All the garments produced are subjected to strict quality assurance checks and inspections.

**Piece goods Quality Control:** Approx. 10% -20% inspection of all piece goods

**Fabric Inspection:** Prior to spreading of fabrics, 4 Points system is followed to classify defects. Defect classification list has been set up to simplify the language and judgment used to make visual fabric evaluation. Rolls are segregated shade wise prior to spreading.

**Cutting Quality Control:** Final patterns are checked thoroughly against measurements provided to control spec. Deviation. Ply numbering stickers and bundling is followed to control shading within lots. Random sampling is done prior to cutting to determine shrinkage and any other characteristic that may exist in the fabric.

**In-Process Quality Control:** In line audits are carried out by qualified inspectors to correct the problem at the sewing level rather than after the garment has been completely assembled.

Quality standards are set up to lay emphasis on critical operations. A separate Q.A Team independent of production has been appointed to evaluate the quality of merchandise being sewn.

**Random Statistical Audit:** After merchandise has been duly checked/inspected by the finishing section, a final audit is carried by our professional Q.C inspectors. Merchandises are audited at 4.0 AQL presently. We are seeking to attain 2.5 AQL in the near future.

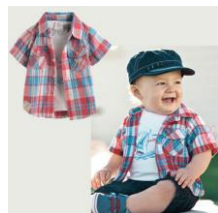
